- Insurance: It was decided to let our insurance policy lapse and review our needs. The policy did not cover much of anything except added fire for Oneonta Lodge. The organization insured was wrong. There were no coverage for punitive damages. We need to cover the officers of the District Association and the Charities Corp. We need event coverage for golf, mystery dinner, etc. Grand Lodge can cover events to a degree, but it is not clear if it is sufficient. Randy is seeking better policies and reviewing coverage. OES needs coverage for the dinner; Bruce will check what Grand Chapter OES covers.
- All lodges should review their policies for proper coverage.
